1. Summary

In November 2019 MCDI and FORVAC entered into partnership to support Community Based Forest Management (CBFM) villages in Lindi Cluster for forest value chains development. Later in August 2020 the collaboration was extended to Ruvuma Cluster. The support has been tailored to the situation in each village and district, depending on whether the Village Land Forest Reserve (VLFR) has an existing valid forest management and harvesting plan, the potential of the community to engage in timber trade and existing capacities of the VNRC.

In early 2021, FORVAC aims to extend its CBFM to support VLFRs in forest value chains development to Tanga Cluster, to cover the following districts/areas:

- Handeni and Kilindi districts in Tanga region, and
- SULEDO community forest in the District of Kiteto, Manyara region.

Based on experience gained in Lindi and Ruvuma Clusters, MCDI is being sought to do similar forest management support in Tanga Cluster. However, before embarking fully on field implementation a needs and resources assessment was critical to be conducted to create a fully informed and effective plan. MCDI was therefore engaged to undertake the assignment.

This report summarises the tasks of conducting Needs and Resources Assessment for CBFM value chain development in Tanga cluster. It details how the assignment was carried out, the findings, challenges observed and the recommendations. The assignment was conducted in January 2021 in collaboration with Local Government Authorities (LGAs) staff from the Regional and District Authorities.

The major focus was to assess CBFM gaps through Focus Group Discussion at District and village levels, conduct equipment needs assessment followed by a rapid assessment (through transect walk) to identify the potential of the VLFRs for forest value chain development.

In the course of undertaking the assignment, seventeen (17) villages were visited in two Regions and three Districts as listed below:

1. Manyara Region, Kiteto District

13 villages: Sunya, Asamatwa, Loltopes, Olgira, Laiseri, Lengatei, Lesoit, Olkitikiti, Eng'ongongare (Mтуру), Mesera, Ndotoi, Zambia and Chang'ombe villages.

2. Tanga Region, Handeni District

3 villages: Kwedikabu, Gole and Kitumbi

3. Tanga Region, Kilindi District

1 village: Mnkonde

2. Methodology

The assignment was carried out in a participatory manner by involving key people who are directly or indirectly involved in CBFM processes at various stages. A total of 308 people were consulted and interviewed. (**Annex 2**)

At Regional level:

In Manyara, meeting was held with the Regional Commissioner, Regional Administrative Secretary and the Regional Natural Resources Advisor. The Regional Natural Resources Advisor also participated in conducting fieldwork.

In Tanga consultation was made with the Regional Natural Resources Advisor who was involved during subsequent meetings at the District and Village levels as well.



Consultations with Kiteto District Commissioner.

District level.

Meetings and consultations were held with the District Commissioners, District Administrative Secretaries, District Executive Directors and the District Field Teams. **(Annex 1).**

Village level:

Introductory meetings were held with members of the Village Council and Village Natural Resources Committees. In SULEDO the village patrol teams (locally known as Sungusungu) were also involved.

This was followed by Focused Group Discussions with Village Council and Village Natural Resources Committee members. In Kiteto Focused group discussions were also held with SULEDO Zonal Environmental Committee and the patrol team.



The forest management plans and associated harvesting plans were reviewed as part of the assessment.

- SULEDO community forest potentiality was gauged through Forest Rapid Assessment conducted in 13 Villages by laying a 2km long and 10m wide walking transect equivalent to 2 hectares in each village where the forest potentiality, disturbance and the dominant timber tree species were assessed.
- CBFM gaps were identified at the village and district level through the review of forest management documents such as Forest management plans and Village reports.
- Community awareness on CBFM, data management, good governance and harvesting operations status observed through Focus Group Discussion in 17 Villages.

3. Key findings, challenges and recommendations

A. Kiteto District (SULEDO Community Forest Reserve)

Key findings:

- (i) SULEDO Forest Management Plan and associated Harvesting Plan is out-dated. It expired five years ago 2016).
- (ii) Limited awareness on forest boundaries leading to land-use conflicts between communities surrounding SULEDO forest reserve. This was observed in Lengatei and Eng'ongongare villages.
- (iii) There are no clear boundary marks for SULEDO forest.
- (iv) Limited technical capacity: SULEDO Zonal Environment Committee (ZEC), Village Environmental Committees and Village Councils have inadequate skills and knowledge on

- CBFM issues such as harvesting and safety procedures, record management, financial management, financial & business planning and good governance.
- (v) At the end of VNRC tenure, fresh new members are elected without retaining any representation from the old committee leading to a lack of knowledgeable members to pass CBFM knowledge to new elected VNRC members.
 - (vi) SULEDO community forest is not ran as a commercial forest enterprise eg There is no business plan both for the community owned sawmill and the forest management.
 - (vii) Ssawmill operators are taking advantage of the community lacking sawmill operating skills to inflate maintenance cost and availability of sawmill spare parts when there is a sawmill break-down.
 - (viii) The stationary sawmill is automated not easy to operate with local community circumstances.
 - (ix) Village environmental committees have inadequate awareness on their roles and responsibilities.
 - (x) No funds are set aside for Village Environmental Committees for them to do forest management activities.
 - (xi) The distribution of revenue generated is not clearly stipulated in the forest management plan.
 - (xii) The forest map is not included in the management plan
 - (xiii) Enabling environment: There is strong political buy in as demonstrated by the RC, DC, DED and Kiteto Member of Parliament.
 - (xiv) The forest is viable for sustainable timber trade and has great potential to deliver more conservation and financial returns.
 - (xv) Inadequate timber markets
 - (xvi) Secure land tenure because SULEDO forest was gazetted through Government Notice in 2007.
 - (xvii) Besides being encroached, a large part of the SULEDO forest cover is still intact.
 - (xviii) Human settlement: One new village (Ndotoi) is found within the forest reserve.
 - (xix) Availability of one field vehicle, a tractor and a grounded stationary sawmill.
 - (xx) SULEDO is potential for Forest certification.
 - (xxi) Lack of new CBFM books
 - (xxii) Both Farmers and livestock keepers from the 13 villages indicated interested and willingness to conservation of the SULEDO community forest, mostly for selling carbon.
 - (xxiii) There is long-term boundary dispute between Kilindi and Kiteto districts
 - (xxiv) Structure of SULEDO community forest management committees differ from the committees managing VLFR in Lindi and Ruvuma clusters (SULEDO community forest committees include Zonal environment committee, village environment committee, Village council and Sungusungu (Patrol Team), Committee managing VLFR in Lindi and Ruvuma include village natural resource committee and village council)

Challenges:

- (i) Encroachment within the SULEDO forest reserve by farmers, livestock keepers and illegal loggers

- (ii) Inadequate forest operations gears (uniforms, first aid kit, GPS, motorbikes, ID cards). The issue was raised by the communities themselves.
- (iii) Regular breakdown of wood processing machinery (WOODMIZER) due to low capacity in processing hardwood and lack of qualified and skilful community representatives to operate the sawmill leading to high operating costs
- (iv) Lack of reliable markets for forest products.
- (v) Human settlement inside the VLFR. (Ndotoi village).
- (vi) Sawmill is ran by electricity.

Rapid assessment in Olgira village (SULEDO)

Recommendations:

- (i) Due to encroachment by farmers and the establishment of a new village (Ndotoi) inside SULEDO, there is a need to re-survey the forest boundaries to exclude the encroached areas.
- (ii) SULEDO forest boundaries need demarcation by placing visible permanent marks using paints as well as installation of signposts with various warning.
- (iii) The SULEDO forest management plan and associated harvesting plan should be reviewed, the periodic review should be after every five years.
- (iv) Intensive capacity building is required to ZEC, VCs, Patrol team & VNRCs members on Community Based Forest Management, contract negotiations skills and customer care, proper filling of CBFM books, Biodiversity monitoring, First aid, Use of GPS, Sawn timber production and timber air drying, Harvesting procedures, Timber measurement and volume calculation, Quota management, record keeping, financial management, marketing strategies, financial & business planning and good governance.
- (v) The WOODMIZER sawmill need repair. The actual costs of repairing the sawmill must be investigated.
- (vi) Intensive training on sawmill operations, maintenance and saw doctoring should be arranged to some of the ZEC, VC, VNRC and ordinary members of the communities.
- (vii) Given the expansive nature of SULEDO a mobile sawmill of the type Norwood HD36 LumberPro is recommended. This model of sawmill is highly recommended due to its tested and proved high efficiency in processing the very hard African wood species and low operating cost compared to WOODMIZER.
- (viii) A petrol engine mobile sawmill with bandsaw technology will be most ideal for SULEDO
- (ix) A business plan for the sawmill should be developed.
- (x) During the election of new VNRCs, at least half of the members should remain to provide experience to new elected VNRCs.
- (xi) The distribution of revenues should be clearly stipulated in the forest management plan
- (xii) Deepening new political support
- (xiii) Based on the experience and lesson learnt from Makame WMA (kiteto) for selling carbon, SULEDO community have showed interest in selling Carbon. Therefore, there certifying SULEDO for carbon credit should be explored in the long term.
- (xiv) There is a need to review administrative system of SULEDO community forest and lay down clearly the roles and responsibilities of each committee (Zonal Environment Committee, Village Environment Committee and patrol team (Sungusungu)). Also,

revenue distribution should take into consideration the weight of the responsibility for each committee.

B. Handeni & Kilindi Districts (Mnkonde, Kwedikabu, Kitumbi and Gole Villages)

Key findings:

- (i) Great interest and willingness of the District Authorities (right from the DC, DED and other LGA Officials) hence high chances of CBFM to succeed and sustainability.
- (ii) VCs & VNRCs have inadequate knowledge on Forest management.
- (iii) VNRC members elected without any set up of eligibility criteria.
- (iv) Most of the small-scale wood workshops in Mkata town depend on illegally harvested forest resources.
- (v) Existence of approximately 90 villages with forests potential for CBFM.
- (vi) The absence of visible marks along the village forest reserve boundaries and signposts in Mnkonde VLFR.
- (vii) Four Management Plans have been endorsed by FBD
- (viii) There is a pending court case at high court (Land division) between Gole Village against an intruder to the VLFR.

Challenges:

- (i) Encroachment by illegal loggers, farmers and pastoralists in the Community forest reserves.
- (ii) Inadequate field equipment (Uniforms, First aid kits, GPS, Motorbikes and field tents) to facilitate forest management activities.
- (iii) Lack of integrity for some members of the village natural resources committee during patrols leading to increased illegal harvesting cases, encroachment by farmers and pastoralists within the forest reserves.
- (iv) Lack of reliable markets for forest products.
- (v) Absence of CBFM books and hammer for legalizing timber harvested from the VLFRs in Kilindi District.
- (vi) Forest fires especially during the dry season

Recommendations:

- (i) VCs & VNRCs to be capacitated with various training on Community Base Forest management ,Contract negotiations skills and customer care, proper filling of CBFM books, Biodiversity monitoring, First aid, Use of GPS, early burning, sawn timber production, and timber air drying, Harvesting procedures, timber measurement and volume calculation, quota management, record keeping, financial management, marketing strategies, financial & business planning and good governance)
- (ii) Restoration of degraded areas.
- (iii) Until such a time when enough revenues are generated from the VLFRs, explore the possibility of supporting the VNRCs with field equipment (uniforms, first aid kit, GPS, motorbikes and ID cards) to facilitate forest management activities.

- (iv) Small-scale wood workshops in Mkata town to be engaged and capacitated on forest regulations, harvesting guidelines /protocols to ensure they are doing legal timber business and sourcing from VLFRs.
- (v) Mnkonde forest boundaries need demarcation by placing visible permanent marks using paints as well as installation of signposts with appropriate warning .
