EXECUTIVE SUMMARY

Forestry and Value Chains Development (FORVAC) is a 4-year Programme (7/2018 – 7/2022) funded by the Ministry for Foreign Affairs of Finland (MFA Finland). It aims to contribute in increasing economic, social and environmental benefits from forests and woodlands. The expected outcome of the Programme is "Improved forest sector market / value chains contributing to sustainable forestry and forest-based livelihoods".

The implementing agency of the FORVAC Programme is the Forest and Beekeeping Division (FBD) of the Ministry for National Resources and Tourism (MNRT). Additionally, the Programme works in close cooperation with Tanzania Forest Service (TFS) and the President's Office Regional Administration and Local Government (PO-RALG). The Programme supports commercialization and improvement of the value chains together with the private sector, local communities and NGOs under Community Based Forest Management regime in three clusters:

- Tanga Cluster, covering Handeni and Kilindi districts in Tanga region, the district of Mpwapwa located in Dodoma region and Suledo Community Forest in Kiteto district of Manyara region;
- Lindi cluster, covering Liwale, Ruangwa and Nachingwea districts; and
- Ruvuma cluster, covering Namtumbo, Tunduru, Songea, Mbinga and Nyasa districts.

Workplan

The Annual Workplan and Budget for the Year 4 (July 2021 – June 2022) is in line with the overall workplan and budget included in the approved Programme Document and follows the established results framework. The human rights based approach (HRBA) of the MFA Finland as well as contribution of the Programme support to climate change adaptation and mitigation are built in the workplan. The workplan is summarized by Outputs below.

Output 1 "Improved value chains and increased private sector involvement in the forest sector" covers the following two interventions:

- 1.1 Support to establishment and mobilization of Village Land Forest Reserves (VLFR); and
- 1.2 Support to value chains development.

Being largely a capacity building program, FORVAC works on increasing the capacities in CBFM and related value chain development from the community level to the districts and further the national level and the scientific community.

The activities supported and included in the Output 1 Workplan are set out below.

Output 1 Improved value chains and increased private sector involvement in the forest sector

- Printing and handover of 20 Village Land Use Plans (VLUPs) from the years 2020 2021.
- 26 Forest Management Plans, combined with Timber Harvesting Plans, produced and approved at the relevant levels: village, district, national/MNRT: 19 in Lindi, 6 in Ruvuma, and 1 in Tanga Cluster. Related capacity building to VNRCs.
- Gazettement of 14 VLFRs to further strengthen ownership: 2 in Tanga Cluster, 6 in Lindi and 6 in Ruvuma Cluster.
- Dashboard for reporting illegalities to be further introduced in Ruvuma and Tanga Clusters.
- Piloting an alternative administrative structure for allocation of land for beekeeping business in Tanga: establishment of beekeeping reserves and related gazettement.
- In cooperation with Tanzania Forest Research Institute (TAFORI) and Sokoine University of Agriculture (SUA), piloting CBFM charcoal production model in two (2) VLFRs in Tanga Cluster, support to related research.
- Support to institutional arrangements/business models with market linkages (e.g. MoUs, joint ventures, PPP & other partnerships, groups/association/cooperative initiatives): marketing, exposure visits for buyers, market and negotiations facilitation, marketing events, association initiatives.
- Field visits for the buyers organized to facilitate cooperation and business relationships between community producers and buyers, related facilitation from FORVAC.
- Procurement and set-up of additional four (4) mobile sawmills and two (2) solar kilns, co-financing repair and maintenance of SULEDO sawmill.

- Support local communities' capacity to run the mobile sawmills and solar kilns, further training on operation and maintenance.
- Review of technical capacities of processors at the district, regional and national levels, and their potential as buyers of community timber, assess the market for kiln dried timber and lesser-known species.
- Establishment of an open-access miombo timber species database, promotion of lesser-known species.
- Production of the product catalog for VLFRs as a tool for market information (market information system).
- Support VLFRs in harvesting contracts.
- Piloting production of bamboo and manufacturing of bamboo products.
- Support to the local Timber Growers' Associations (TGAs) in four (4) villages in Nyasa district: additional 100 ha of Teak plantation established; in the selected sites combined with promotion of intercropping (conservation agriculture / agroforestry).
- Call for Business Proposals community level: approximately 100 individual community-based enterprises and/or producer groups supported through an 8-month mentoring program and investment support scheme.
- Mezzo/national level business support: Identify and support additional business partnerships by regional and national actors with producers in CBFM villages. This also covers private sector engagement in honey production, processing, and marketing.
- Contributing to FSC certification in six (6) villages.

Output 2 "Stakeholder capacity to implement and promote forestry value chain development enhanced" is implemented through the following three interventions:

- 2.1 Improved institutional and management capacities of Village Councils and VNRC to implement CBFM and develop forest value chains;
- 2.2 Improved capacities to support and monitor CBFM/forest and related value chains, incorporating HRBA aspect; and
- 2.3 Forest products value chain/market systems and business development skills incorporated in relevant training institutes.

The related workplan covers the following major inputs:

Output 2 Stakeholder capacity to implement and promote forestry value chain development enhanced

Community level

- Awareness raising/training for Village Natural Resources Committees (VNRCs)/Village Councils on laws and regulations related to CBFM.
- · Awareness raising and training to village institutions on CBFM related benefit sharing.
- Educating communities on their rights and benefits from sustainable forest management, CBFM and fair benefit sharing: supporting the existing MJUMITA networks in relevant areas for enhancing village forest governance in the FORVAC operational area.
- Training on financial aspects (feasibility calculations, business planning), microfinance and fund-raising activities for the development of new value adding activities.
- Supporting producers' fund raising through VICOBA/VSLA models.
- Exchange visits to successful interventions of CBFM and forest value chain development.

District, regional and national level authorities/institutes

- Capacity building on Participatory Forest Management (PFM)/Community-based Forest Management (CBFM), land use planning (LUP), and laws and regulations related to value chain development, events for district level authorities.
- Co-facilitating CBFM stakeholder forum in Ruvuma region.
- Training to district staff on value chain development.
- Exchange visits to successful interventions of CBFM and value chains development.
- Training for district authorities on management of land use and forestry related conflicts.

Education, training institutes

- Planning of a process for establishment of a value chain development (VCD) module to the curricula of selected institutes.
- Support studies (thesis/dissertations) of MSc students related to forest products value chains/market system and business development relevant to CBFM and achievement of the FORVAC's objectives.
- Sharing of the results from the International Scientific Conference: produce a report for wider audience, also popularized material for community level to deliver information to the stakeholders.

Output 3 "Functional extension, communication, monitoring systems and Management Information System in place" will be produced by implementing the following interventions:

- 3.1 Enhanced extension and communication services; and
- 3.2 Monitoring and Management Information System (MIS) established.

The main activities covered by the workplan are given below:

Output 3 Functional extension, communication, monitoring systems and Management Information System in place

- Participating in forestry and beekeeping related events (Saba Saba, Beekeeping & Tree planting day, Nane Nane): support CBFM communities' and other key stakeholders' participation in selected events that clearly contribute to the achievement of the FORVAC's objectives/results.
- Facilitate media tours to FORVAC activities, engage media in documenting CBFM/VCD, production of documentaries on the FORVAC success stories.
- Develop implementation strategies and extension manuals of forestry and beekeeping policies.
- Support in development of policy reviews and necessary guidelines for Tanzanian forest and beekeeping industries relevant to the CBFM context.
- Awareness raising to youth on sustainable forestry and related livelihoods, development of materials and organizing awareness raising events in selected schools.
- Support district and national authorities in monitoring of FORVAC interventions: review and planning workshops biannually, backstopping/joint monitoring visits by the District Councils and relevant regional and national level authorities.
- PFM Facts and Figures 2020 layout, printing and distribution, and further development of the VLFR database (finalize database, facilitate data input).
- Satellite image-based monitoring of development of forest coverage (deforestation) and climate change adaptation and mitigation in the Programme area.
- Programme exit strategy and impact studies.

Output 4 "Supportive legal and policy frameworks to forest value chain and sustainable forest management developed" will be produced through the following two interventions:

- 4.1 Improved policy and regulatory framework for forest value chain development; and
- 4.2 Support to development of forest law enforcement, forest governance and trade of legally sourced timber.

These interventions include the following major activities:

Output 4 "Supportive legal and policy frameworks to forest value chain and sustainable forest management developed"

- National workshop on policies and laws, and challenges related to CBFM and its value chains.
- Further development of the Natural Forest Management Planning Guidelines, printing of guidelines.
- Taskforce meetings to review the National Forest Act No 14 of 2021, printing of the Forest Act, developing popularized versions of the Act for use at the community level.
- Printing and dissemination of the Forestry and Beekeeping Policy Implementation Strategies and Extension Manuals.
- Support to development of the National Charcoal Strategy and its dissemination.
- Facilitate workshops and FGDs on operationalization of checkpoint data management system in collaboration with TRAFFIC/TFS.
- Support workshop to discuss illegal logging and Tanzania Timber Legality Framework in cooperation with TFS/TFWG/TRAFFIC, support dissemination of the framework, including production of a popularized version for the community level.
- Development of Chain of Custody for VLFR timber, pilot tracking of Tanzanian community timber, also including appropriate technical solutions from the stump to the end user.

Resource allocation

The main implementation modality in the Programme is through service providers of different kind at different levels. Additionally, 32 days of short-term consultancies are included in the workplan, covering the Programme End Impact Study in 2022.

Budget

A total budget of the AWP from July 2021 to June 2022 is EUR 3,024,862 (TZS 8,167,128,200), covering the following finance for i) Operations and management; and ii) Technical assistance (TA):

i) Operations & management:	EUR 2,642,559
ii) Technical assistance (TA, including ST consultancies):	EUR 382,303
Total:	EUR 3,024,862

A total of EUR 55,634 (Operations and management EUR 25,189; TA budget EUR 30,445) remains for the last month of the Programme, July 2022, which is not included in this workplan (the Programme closure will take place on 22 July 2022).

Textbox below summarizes the budget of the planning period specifically for Operations and management. These numbers do not cover the cost of the technical assistance (TA).

The allocated finance also includes the amount used to support implementation of the bridging phase of the PFP Programme, EUR 273,768 (TZS 684,421,200) in total. It has been agreed that this finance will be reimbursed to the FORVAC budget.

Programme monitoring

The key mechanisms and processes of the Programme monitoring include:

- Information collection by the Programme personnel.
- Data collection and progress reports from districts, based on formal discussions with PO-RALG and districts.
- Progress reports from Service Providers.
- Joint monitoring visits to the Programme sites with both central and district level authorities.
- Field monitoring visits by the FORVAC team members.

International Junior Expert (IJE) assists the Programme Management Team (PMT) in M&E related duties.

Moreover, we include in the Annual Workplan and Budget a joint monitoring mechanism. In the target districts relevant district officers, also involving representatives of PO-RALG and TFS, conduct monitoring visits to assess Programme supported activities and report findings. Periodically also representatives of the central level authorities join these monitoring missions.

In addition to the Programme's own monitoring systems, the MFA has contracted an external review and evaluation team (ERET) to support systematic M&E of FORVAC. Additionally, the FORVAC team will develop the Programme exit strategy and organize end of the Programme impact studies in April – May 2021.

1 BACKGROUND AND SITUATION

1.1 Background

Forestry and Value Chains Development (FORVAC) is a 4-year Programme (7/2018 – 7/2022) funded by the Ministry for Foreign Affairs of Finland (MFA Finland). It aims to contribute in increasing economic, social and environmental benefits from forests and woodlands. The expected outcome of the Programme is "Improved forest sector market / value chains contributing to sustainable forestry and forest-based livelihoods".

The FORVAC builds on the activities, experiences and lessons learned from three bilateral programs financed by Finland in Tanzania: National Forest and Beekeeping Programme (NFBKP II, 2013–2016), Lindi and Mtwara Agribusiness Support (LIMAS, 2010–2016), and Private Forestry Programme (PFP 1, 2014–2019). NFBKP II and LIMAS have worked under the Community-Based Forest Management regime to advance sustainable forest management and generate income and employment to communities from declared Village Land Forest Reserves. Participatory Plantation Forestry Programme (PFP 2, 2019 – 2023) is working solely in plantation forests but, together with PFP 1, has created valuable experiences to share in value chain development, mobilization of rural communities for economic activities, and developing training and extension services for small-scale forest enterprises.

FORVAC focuses on forest value chain development based on production of timber, charcoal and Non-Wood Forest Products (NWFP) in the Programme districts and areas allocated there to local communities (CBFM within Village Land Forest Reserves). The Programme also supports the development of forest law enforcement, as it is relevant to the development of CBFM, and improvements of conditions for the trade of legally sourced timber, charcoal and other forest products originating from the Programme area. Legal and policy frameworks are improved and harmonized to guide and improve sustainable forest management and trade procedures.

The implementing agency of the FORVAC Programme is the Forest and Beekeeping Division (FBD) of the Ministry for National Resources and Tourism (MNRT). Additionally, the Programme works in close cooperation with Tanzania Forest Service (TFS) and the President's Office Regional Administration and Local Government (PO-RALG).

Starting from the beginning of the Programme Year 3, July 2020, FORVAC operations have been extended also to cover the district of Kiteto (Suledo Forest Community) in Manyara region and Tunduru district in Songea region. After this extension, the Programme will support commercialization and improvement of the value chains together with the private sector, local communities and NGOs, applying CBFM approach, in the following three Clusters:

- <u>Tanga Cluster</u>: Handeni and Kilindi districts in Tanga region, the district of Mpwapwa located in Dodoma region and the district of Kiteto (Suledo Forest Community) in Manyara region
- Lindi Cluster: Liwale, Ruangwa and Nachingwea districts
- Ruvuma Cluster: Namtumbo, Tunduru, Songea, Mbinga and Nyasa districts

Results framework

The FORVAC Results Framework is set out in the Programme Document. It is also presented in this paper as part of Annex 1 (Planning Matrix for Annual Targets), indicating results (Impact, Outcome and Outputs), related indicators, baselines, annual targets, end of Programme targets, means of verification and assumptions. Furthermore, the Programme Results are given below:

Impact: Increased economic, social and environmental benefits from forests and woodlands

Outcome: Improved forest sector market / value chains contributing to sustainable forestry and forest-

based livelihoods

The outcome will be achieved through the accomplishment of the following four outputs:

- Output 1: Improved value chains and increased private sector involvement in the forest sector
- Output 2: Stakeholder capacity to implement and promote forestry value chain development enhanced
- Output 3: Functional extension, communication, monitoring systems and Management Information System in place
- Output 4: Supportive legal and policy frameworks to forest value chain and sustainable forest management developed

1.2 Situation

After implementation of the second half of the Annual Workplan 2019 – 2020 under the influence of the COVID-19 pandemic, FORVAC had to establish an ambitions workplan and budget for the Programme Year 3 in order to limit the pandemic caused delay and further postponement of the planned activities. The Annual Workplan and Budget (AWP) from July 2020 to June 2021, including Cluster level plans and the workplan for the Programme coordination (PMU) and related budgeting, was prepared in May – June 2020 and approved by the FORVAC Steering Committee on 18 June 2020, and endorsed without changes by the Supervisory Board on 6 November 2020.

As given in the Annual Report from July 2020 to June 2021, during Year 3 FORVAC has taken a shift from operations previously largely focused on adding forest area under sustainable forest management (Land Use Planning, Forest Management Planning) to value chain development. Still, additional 18 Village Land Use Plans (VLUPs) were developed and are currently waiting for the approval, and 28 Forest Management Plans (FMPs) completed for Village Land Forest Reserves (VLFRs) during the reporting period.

The following important partnerships and service provision contracts were either established or extended:

- i) FORCONSULT SUA, Service Contract for Support to MSc Dissertations (6 studies supported by July 2021)
 - August 2019 September 2020 and Nov. 2020 July 2021 (new contract for 2 studies for October 2021 – May 2022)
- ii) FORCONSULT/SUA, Department of Forest Engineering and Wood Sciences: Study of Lesser-known Tree Species, establishment of a Database for Miombo Timber Species
 - June 2020 September 2021
- iii) MCDI Partnership on developing improved forest-based income, livelihoods and environmental benefits deriving from CBFM in FORVAC Lindi Cluster, since September 2021 covering 34 villages in the districts of Liwale, Nachingwea and Ruangwa
 - November 2019 August 2020, extended for September 2020 August 2021 (ongoing, to be further extended)
- iv) MCDI Partnership on developing improved forest-based income, livelihoods and environmental benefits deriving from CBFM in Ruvuma Cluster, covering 11 villages in the districts of Songea, Namtumbo and Tunduru
 - August 2020 August 2021 (ongoing, to be extended)
- v) Sustainable Environment and Livelihood Limited (SEL): Establishment of eight (8) Village Community Banks (VICOBA groups) in Tanga Cluster (Handeni, Kilindi and Mpwapwa districts); establishment of the eleven (11) VICOBA groups in Mbinga and Nyasa Districts in Ruvuma Cluster
 - May August 2020 (Tanga Cluster) and February June 2021 (Ruvuma Cluster)
- vi) MJUMITA: partnership on development of Village Forest Governance in Tanga and Ruvuma Clusters
 - May 2020 February 2021, extended until May 2021 (new contract to be signed for 7/2021 3/2022)

- vii) SEDIT: Mentoring and Investment Support Services for Community Level Micro-Business Initiatives
 - October 2020 June 2021
- viii) Mamsteen Consultants Limited: Service Contract for village land use planning in 15 villages in Lindi and Ruvuma Clusters.
 - December 2020 September 2021

In addition to the above processes, the Programme established the FORVAC website (https://forvac.or.tz/) in August – September 2019 and the Programme Management Information System (MIS) in August – October 2019. Both of them contribute to the FORVAC implementation (M&E, communication) to the end of the Programme.

Mid-term Evaluation of the Programme

The donor agency has contracted a team of consultants to run external reviews and evaluations of MFA Finland funded programmes in Tanzania. The FORVAC mid-term evaluation took place in this context in March – April 2021, with the following assignment:

- Assess relevance, coherence, efficiency, effectiveness, impact, and sustainability of the Programme;
 and
- Observe and record findings and draw conclusions and recommendations for remaining implementation period and beyond FORVAC, also assessing needs for possible extension.

These elements and related findings, conclusions and recommendations are further described in the Mid-Term Evaluation Report. Herewith we summarize major recommendations given by the ERET team:

- Explore the options for extension of the Programme for two (2) years using the current contract and Programme set-up to avoid a large gap between phases and to enable the current team to achieve sustainable results without the need to retender.
- The extension could be based on a combination of no-cost extension (to use the remaining unused funds on Programme activities) and a with-cost extension especially for Programme management and TA costs, making use of the option included in the contract with the implementing Consortium (FCG). The contract allows for an extension of a maximum of 24 months.
- Facilitate further dialogue between key stakeholders in the sector to improve consensus on the value chain strategy and CBFM approach in general and influence policy.
- Identify the options for an improved village selection strategy for the next phase, including the possibility of a clustered approach of villages within the landscape that integrates not only the communities with large intact forests but also those that have less potential for timber value chain.
- Make improvements to the design aspects: i) Review the operational strategies and contribution of
 the Programme on HRBA and identify options on how the Programme can further improve gender
 equality (especially in decision-making processes) and address the interests of youth and vulnerable
 people. ii) Revise the Results Framework to improve its vertical and horizontal logic and make the
 indicators SMART and realistic.
- Improve collaboration with other key stakeholders and development partners in the sector.
- Address the issues caused by delays without compromising the quality of implementation for the remaining period of the Programme: i) As part of the revision of the Results Framework, revise the targets to make them realistic; ii) reallocate the budgets between the different operational activities and outputs, based on a realistic assessment of the remaining activities.
- MFA to approve the proposal submitted by FORVAC for additional funds to alleviate the shortage on management budget and finance inputs by the VCDA, Short-term Consultants and Junior experts.
- To increase effectiveness, more emphasis could be put on the charcoal/biomass energy value chains

and on policy-related work to help improve the regulatory aspects and enabling environment for CBFM and especially the timber-and charcoal value chain.

Annual Workplan and Budget

This document presents the workplan and budget of FORVAC for Year 4 of the Programme, for the period from 1 July 2021 to 30 June 2022. It incorporates the valuable findings and recommendations from a number of key supporting interventions that have taken place during the first three years of the FORVAC implementation such as:

- Finalizing the Programme Document, including the Results Framework and the Overall Workplan and Budget 2018 2022;
- Market system analysis (MSA);
- Formulation of the FORVAC Communication Plan;
- National Charcoal and Biomass Energy Assessment;
- Assessment of opportunities for the development of FLEGT and improved conditions for trade of legally sourced timber in the FORVAC context;
- Baseline data collection and incorporation of new districts;
- Training Needs Assessment (TNA);
- Experiences gained from the previous Programme years (Annual Report 7/2018 6/2019, Annual Report 7/2019 6/2020 and the Annual Report 7/2020 6/2021);
- Formulation of PFM Facts and Figures 2020 and establishment of a Miombo Timber Species Database;
- Development of the Proposal for CBFM Apex Body (June November 2020);
- Identification of CBFM based value chains in the context of the FORVAC's community level microbusiness support (August 2020 – June 2021); and
- Needs and Resource Assessment of CBFM in Tanga Cluster (January February 2021).

The above mentioned interventions have provided valuable information through relevant findings and analysis of needs at different levels and in different areas, contributing to elaborate more specific priority interventions and modalities within the Programme framework.

Additionally, the FORVAC team has communicated findings, conclusions and recommendations of the Mid-Term Evaluation with the ERET team, and they, based on preliminary findings, have also been discussed in the Programme Steering Committee meeting on 23 March. Moreover, specific debriefing was held to the entire team of FORVAC on 19 May 2021. Based on this communication and the evaluation report, the team has accommodated conclusions and recommendations in the AWP 2021 – 2022 as feasible and will take this important guidance into account during the implementation.

2 OUTPUTS AND INDICATORS OVER THE PLANNING PERIOD

2.1 Outputs and indicators

The FORVAC Results Framework is set out in the Programme Document. It defines the results (Impact, Outcome and Outputs), related indicators, baselines, end of Programme targets, means of verification and assumptions. In addition to the same information, the Planning Matrix set out in Annex 1 of this document gives annual targets for the indicators. Herein we summarize the annual targets by Outputs.

Output 1. Improved value chains and increased private sector involvement in the forest sector

During the planning period (July 2021 – June 2022), FORVAC implementation will focus on the activities contributing to production of Output 1, with two major interventions, namely:

- 1.1 Support to establishment and mobilization of Village Land Forest Reserves (VLFR); and
- 1.2 Support to value chains development.

Indicators and annual targets of Output 1 are given in Table 1 below. Activity level targets are set out for the Programme and the Clusters in the Annual Workplan (Annex 2).

Output 2. Stakeholder capacity to implement and promote forestry value chain development enhanced FORVAC conducted a comprehensive Training Needs Assessment (TNA) in 2019. Training in terms of value chain is needed both at the community and district levels.

Output 2 is implemented through the following three interventions:

- 1.1 Improved institutional and management capacities of Village Councils and VNRC to implement CBFM and develop forest value chains;
- 1.2 Improved capacities to support and monitor CBFM/forest and related value chains and incorporating HRBA aspect; and
- 1.3 Forest products value chain/market systems and business development skills incorporated in relevant training institutes.

Indicators and annual targets of Output 2 are given in Table 2 below. Activity level targets are set out for the Programme and the Clusters in the Annual Workplan (Annex 2).

Output 3. Functional extension, communication, monitoring systems and Management Information System in place

Output 4. Supportive legal and policy frameworks to forest value chain and sustainable forest management developed

FORVAC will support the development of Guidelines (CBFM books) and the approval of the updated forest legislation (Forest Act and regulations). FORVAC will also support the dissemination of the updated Forest Policy, and the National Assessment on the Charcoal sector results. To curb the illegal logging, FORVAC will also support the establishment of a Timber Legality Manual in Tanzania.

Output 4 will be produced through the following two interventions:

- 4.1 Improved policy and regulatory framework for forest value chain development; and
- 4.2 Support to development of forest law enforcement, forest governance and trade of legally sourced timber.

3 WORK PLAN

The Annual Workplan and Budget for the Year 4 (AWP 2021 - 2022) is in line with the overall work plan and budget included in the approved Programme Document and it follows the established results framework. The human rights based approach (HRBA) of the MFA Finland as well as contribution of the Programme support to climate change adaptation and mitigation are built in the workplan. Moreover, the AWP incorporates valuable findings and recommendations from a number of key supporting interventions that have taken place during the previous Programme years. These are discussed in Section 1.2 of this document and further elaborated in the Annual Report 7/2020 - 6/2021.

The major contents of the Annual Workplan are set out by Outputs below. The complete Workplan, presenting the main priority interventions in the period and specifying activities and sub-activities under each of the four (4) Programme Outputs, also indicating targets and time distribution, is set out in Annex 2. Activities are also given by Clusters. The presentation of the Programme budget, elaborated in Section 4.3, follows the same structure (Annex 3).

3.1 Output 1 Workplan

Herewith we give a brief narration of the Workplan 2021 – 2022 by Outputs. The complete workplan is given in Annex 2.

Output 1 "Improved value chains and increased private sector involvement in the forest sector" covers the following two interventions:

- 1.1 Support to establishment and mobilization of Village Land Forest Reserves (VLFR); and
- 1.2 Support to value chains development.

In the last year of the Programme implementation, the focus will be on the value chain development related activities, and base activities (1.1) will only be done in strategic locations, which contribute to the on-going processes and approaches. These five (5) supported activities focus on establishment and mobilization of the Village Land Forest Reserves (VLFR) and ownership related issues forming the basis for the Community Based Forest Management (CBFM) approach and value chain development supported by the Programme.

The major activities and related targets are as follows:

- Printing and handover of 20 VLUPs produced during 2020 2021.
- 26 Forest Management Plans and with Timber Harvesting Plans produced and approved at the relevant levels: village, district, national/MNRT: 19 in Lindi, 6 in Ruvuma, and 1 in Tanga Cluster. Related capacity building to VNRCs.
- Gazettement of 14 VLFRs to further strengthen the ownership: 2 in Tanga, and 6 in both Lindi and Tanga Clusters.
- Dashboard for reporting illegalities to be further introduced in Ruvuma and Tanga Clusters.
- Piloting an alternative administrative structure for allocation of land for beekeeping business in Tanga: establishment of beekeeping reserves and related gazettement.

All the CBFM communities, which FORVAC has engaged with, will be continued to be supported by FORVAC through varied approaches from forest management planning (if not yet done) to calls for business proposals and facilitating partnerships between communities and market.

Through land use planning, forest management planning and supportive bylaws VLFRs aim at sustainable forest management. This is expected to contribute to climate change mitigation and adaptation.

Improving the business and income generation possibilities around forest products will be in the core of FORVAC activities in 2021 – 2022. Communities are supported in terms of selling sustainable VLFR products, like timber and charcoal, as a community. This support includes improvement of processing, marketing,

facilitating contracts and sales, and it is done in connection with enhancing village forest governance. In addition, FORVAC will support VLFR derived businesses run by community members, often dealing with NTFPs but also e.g. carpentry through micro-business support scheme and Swahili Honey -type partnerships (private sector engagement).

Intervention 1.2 works for value chains development, covering 12 activities dealing with the following main subjects:

- Charcoal production pilot in Tanga Cluster, and related research in cooperation with TAFORI and SUA. To answer to the high demand of charcoal and to tackle one of the biggest deforesting factors, also in relation to VLFRs, we have created an alternative model for charcoal production emphasizing efficiency and technology development. The idea is to allocate (already degraded) parts of the VLFR to efficient & sustainable charcoal production, and with the income, finance strictly protecting the rest. Instead of large beginning investment in plans and inventories, the set up phase would be made as low-cost as possible, and instead, investing in cheap technology attractive. By increasing the efficiency of burning and minimal investment to metal kilns, it should, according to specialists, be possible to double the recovery rates (-> only half of the biomass used for same amount of ready product).
- <u>Support to institutional arrangements/business models with market linkages</u> (e.g. MoUs, joint ventures, PPP & other partnerships, groups/association/cooperative initiatives): marketing, exposure visits for buyers, market and negotiations facilitation, marketing events, association initiatives. This support is applied on-need-basis, e.g. in following situations:
 - Field visits for the buyers organized to facilitate cooperation and business relationships between community producers and buyers, related facilitation from FORVAC.
 - Community enterprises show interest in some particular company/client and are in need of delivering samples/visiting, related facilitation FORVAC.
 - Producers show interest in forming associations to improve bargaining power / cooperation, related facilitation from FORVAC
- Assist communities to improve the quality of timber harvested from community forests and link their
 production with market (demand): support capacity to run the mobile sawmills and solar kilns,
 further capacity building in operations, procure and set-up four (4) mobile sawmills and two (2) solar
 kilns and co-finance the maintenance of SULEDO sawmill.
- Support to <u>timber processing entities to improve efficiency of timber processing</u>: Review of technical capacities of processors at the district, regional and national levels, and their potential as buyers of community timber. Assess the market for kiln dried timber and lesser-known species.
- Establishment of an <u>open-access Miombo Timber Species Database</u> and promotion of lesser-known species; timber species <u>catalog and associated with it the market information system development</u> (<u>MIS</u>) with contacts to CBFM villages, where the different forest species and products are available, included.
- <u>Support VLFRs in harvesting contracts</u>: mentoring, assisting in negotiations and formulation of contracts, linkages with contractors/harvesting companies/buyers. Mainly done in cooperation with MCDI.
- Piloting production of <u>bamboo</u> and <u>manufacturing of products from bamboo</u>. In Ruvuma and Lindi Clusters bamboo businesses exist, and bamboo could be one marketed product form the VLFRs. Especially for VLFRs with low timber resources, bamboo could be a product financing the zeroharvest period, set to let the forest recover. Manufacturing units in district centers will be supported and connected with the near-by VLFRs with bamboo resource.

- Support to TGAs in four (4) villages in Nyasa district: <u>additional 100 ha of teak plantation established;</u> in the selected sites combined with promotion of <u>intercropping (conservation agriculture/agroforestry)</u>.
- Call for Business Proposals community level: <u>approximately 100 individual community-based</u> <u>enterprises and producer groups supported through an 8-month mentoring program and investment</u> support scheme in Ruvuma and Lindi Clusters.
 - The human right based approach (HRBA) shall be applied to the selection criteria, e.g. by using quotas and additional scoring criteria for proposals by vulnerable persons.
- Mezzo/national level business support: Identify and <u>support additional business partnerships by</u> regional and national actors with producers in CBFM villages.
 - Expand the partnership with Swahili Honey to Kilindi (identified as most potential for honey production) in Tanga Cluster.
 - Continue Swahili Honey partnership in Handeni and Mpwapwa.
- Contribute to ongoing FSC certification in six (6) potential villages considering the financial viability of certification.

FORVAC shall take climate change mitigation and adaptation as well as the HRBA specifically into account in developing the selection criteria for the community-level micro-business support as well as mezzo/national level business support addressed to value chains deriving from VLFRs.

3.2 Output 2 Workplan

Being largely a capacity building program, FORVAC works on increasing the capacities in CBFM and related value chain development from the community level to districts and further the national level and scientific community. Output 2 "Stakeholder capacity to implement and promote forestry value chain development enhanced" is implemented through the following three interventions:

- 2.1 Improved institutional and management capacities of Village Councils and VNRC to implement CBFM and develop forest value chains;
- 2.2 Improved capacities to support and monitor CBFM/forest and related value chains and incorporating HRBA aspect; and
- 2.3 Forest products value chain/market systems and business development skills incorporated in relevant training institutes.

First of the above-mentioned interventions (2.1) covers a set of supportive activities addressed to local communities / VLFRs in the Programme target districts. In addition to LGA, FORVAC partners with MCDI and MJUMITA in the capacity building efforts. They include e.g. the following related topics:

- Awareness raising/training for VNRCs/Village Councils on laws and regulations related to CBFM.
- Awareness raising and training to village institutions on CBFM related benefit sharing.
- Educating communities on their rights and benefits from sustainable forest management, CBFM and fair benefit sharing: supporting the existing 16 MJUMITA networks in FORVAC operational area.
- Training on financial aspects (feasibility calculations, business planning), microfinance and fund raising activities for the development of new value adding activities.
- Supporting producers in fund raising through VICOBA/VSLA models; District Community Development Officers will participate in establishment of VICOBA groups and VSLAs.
- Exchange visits to successful interventions of CBFM and forest value chain development.

Intervention 2.2 "Improved capacities to support and monitor CBFM/forests and related value chains, incorporating HRBA aspect" – the proposed set of activities include the following major inputs:

- Capacity building on PFM/CBFM, LUP, and laws and regulations related to value chain development, events for district level authorities, co-facilitating CBFM stakeholder forum in Ruvuma region.
- Training to district staff on value chain development.
- Exchange visits to areas of successful interventions in CBFM and value chain development.
- Study tour to exchange experiences with Tanzanian / Finnish forest extension and community forest management in both countries.
- Training for district authorities on management of land use and forestry related conflicts.

Intervention 2.3 "Forest products value chain/market systems and business development skills incorporated in education/curricula of relevant training institutes" covers following types of activities:

- Formulation of VCD modules for the selected training institutes (FITI/FTI/BTI): planning of a process for establishment of a value chain development (VCD) module to the curricula of 1 2 selected institutes.
- Support studies (three thesis/dissertations) of MSc Students related to forest products value chain/market system and business development relevant for CBFM and achievements of the FORVAC's objectives.
- Sharing of the results from the International Scientific Conference. Produce a report for wider audience and popularized material for community level to deliver information to the stakeholders.

3.3 Output 3 Workplan

Output 3 "Functional extension, communication, monitoring systems and Management Information System in place" will be produced through the following two interventions:

- a. Enhanced extension and communication services; and
- b. Monitoring and Management Information System (MIS) established.

During the planning period, Intervention 3.1 works for development of CBFM related extension and communication services through supporting the following activities:

- Participating in forestry and beekeeping related events (Sabasaba, Beekeeping & Tree planting day, Nanenane), support participation in the selected events that clearly contribute to the achievement of the FORVAC's objectives/results.
- Assists active media committed to forest issues to be further involved in forestry related activities to report and learn about new concepts emerging in the forest sector: media tours to FORVAC activities, developing documentaries of the FORVAC success stories.
- Develop implementation strategies and extension manuals of forestry and beekeeping policies.
- Support in development of policy reviews and necessary guidelines for Tanzanian forest and beekeeping industries relevant in the CBFM context. FORVAC has supported startup and/or operations of several small beekeeping and carpentry businesses, and community owned mobile sawmills. Understanding the policy requirements for these businesses, and further, if needed, developed guidelines could advice in the businesses.
- Awareness raising to youth on sustainable forestry and related livelihoods, development of materials and awareness raising events in selected schools.

During AWP 2021 – 2022, Intervention 3.2 "Monitoring and Management Information System (MIS) established" covers the following activities:

- Support district and national authorities in monitoring of FORVAC interventions: review and planning workshops biannually, backstopping/joint monitoring by the District Councils and the relevant regional and national level authorities.
- PFM Facts and Figures 2020 layout, printing and distribution and further development of the VLFR database (finalize database, facilitate data input).
- Satellite image-based monitoring of development of forest coverage (deforestation) in the Programme area.
- Programme exit strategy and impact studies.

3.4 Output 4 Workplan

Output 4 "Supportive legal and policy frameworks to forest value chain and sustainable forest management developed" will be produced through the following two interventions:

- 4.1 Improved policy and regulatory framework for forest value chain development; and
- 4.2 Support to development of forest law enforcement, forest governance and trade of legally sourced timber.

During the planning period, FORVAC will support the following activities through Intervention 4.1:

- National workshop on policies and laws, and challenges related to CBFM and its value chains.
- Further development of the Natural Forest Management Planning Guidelines (Guidelines for Participatory Forest Resources Assessment, PFRA), printing of guidelines.
- Taskforce meetings to review the National Forest Act No 14 of 2021, printing of the Forest Act, developing popularized versions of the Acts for use in the community level.
- 3,000 copies (in total) of the Implementation Strategies and Extension Manuals printed and disseminated
- Support to development of the National Charcoal Strategy, dissemination.

Intervention 4.2 "Support to development of forest law enforcement, forest governance and trade of legally sourced timber" mostly works to curb illegal logging and illegal trade of charcoal and NWFPs from VLFRs, covering the following activities during the planning period from July 2021 to June 2022:

- Support workshop to discuss illegal logging and Tanzania Timber Legality Framework in cooperation with TFS/TFWG/TRAFFIC.
- Develop and a print popular version of the Timber Legality Framework, support dissemination of the framework.
- Workshops and FGDs on operationalization of checkpoint data management system in collaboration with TRAFFIC/TFS.
- Development of Chain of Custody for VLFR timber, pilot tracking of Tanzanian community timber, also including appropriate technical solutions, from the stump to the end user.

3.5 Capacity development plan

FORVAC conducted a ST-consultancy on training and capacity development needs assessment in May – June 2019 to set up a comprehensive capacity development plan for the Programme. Results of this consultancy are elaborated in the FORVAC document "Training Needs Assessment & Action Plan". This plan as well as other results of the consultancy have been further considered by the FORVAC team and incorporated in the Workplans, including the AWP 2021 - 2022.

3.6 Ongoing activities (commenced during the Workplan 07/2020 – 06/2021)

Service provisions set out in Table 6 below, commenced earlier during the Programme implementation, are still ongoing at the beginning the new planning year 07/2021 – 06/2022. Many of these services shall be extended up to 2022.

4 RESOURCE ALLOCATION AND BUDGET

Human resources directly allocated to the Programme management and other technical assistance for the use of FORVAC are limited. Therefore, the Programme works rather largely through service providers. For this purpose, a mapping of potential service providers has been done through various short-term assignments carried out during the year 1. Experiences gathered from previous implementation years also give guidance for establishment of service contracts and other partnerships.

4.1 Description of human resources in the FORVAC framework

The allocated finance also includes the amount used to support implementation of the bridging phase of the PFP Programme, EUR 273,768 (TZS 684,421,200) in total. It has been agreed that this finance will be reimbursed to the FORVAC budget.

5 MONITORING AND REPORTING

5.1 Monitoring arrangements

The FORVAC PIM Chapter 5 gives outline for Programme monitoring and reporting. The updated FORVAC Results Framework is presented in Annex 1 (Planning matrix for annual targets), indicating results (Impact, Outcome and Outputs), related indicators, baselines, end of Programme targets, annual targets for the planning period, and means of verification and assumptions.

Required baseline data is completely available now, also to be managed through the FORVAC Management Information System (MIS), established in August – October 2019. Additionally, the Programme has commenced establishment of a specific database of VLFRs (VLFR Database).

The key mechanisms and processes of the Programme monitoring include:

- Information collection by the Programme personnel.
- Data collection and progress reports from districts, based on formal discussions with PO-RALG and districts.
- Progress reports from Service providers.
- Field monitoring visits by the Programme team members.

An International Junior Expert (IJE) joined the FORVAC team in August 2020 to assist the PMT in M&E related duties.

Additionally, we include in the Annual Workplan and budget a joint monitoring mechanism. In the target districts, the relevant district officers, also involving representatives of PO-RALG and TFS, conduct monitoring visits to assess Programme supported activities and report findings. Periodically also representatives of relevant central level authorities join these monitoring missions.

In addition to the Programme's own monitoring systems, the MFA Finland has contracted an external review and evaluation team (ERET) to support systematic M&E of FORVAC.

5.2 Reporting

The reporting on Programme progress by the relevant actors, as described in 5.1, is done as follows:

- The financial expenditure reporting and MIS activity reports: monthly and quarterly basis (based on the arrangements described in the Programme Implementation Manual, PIM).
- Semi-Annual and Annual Reports: Semi-Annual Report, covering yearly the months from July to December in January; Annual Report from July to June of the following year shall be submitted in June – July.

Feedback on the Programme progress will be provided to the districts/PO-RALG and service providers. The feedback includes discussions and agreement on corrective measures when needed.

The FORVAC reporting procedure is set out in the FORVAC PIM. It follows the guidance of the MFA Manual for Bilateral Programmes. It also serves the FBD's M&E function. The annual reports include an analysis of the risks and realization of the assumptions, which is essential information for the steering of the Programme. In addition, the contributions from the GoT are reported on annual basis. Circulation and dissemination of results and lessons learned is required to improve the sustainability and impact of the Programme. The models for dissemination have been defined in the FORVAC Communication Plan 2018-2022.

6 ASSUMPTIONS AND RISKS

6.1 Assumptions

The main assumptions previously identified and presented in the Programme Document still remain and they are not commented in this Annual Workplan 2021 – 2022. However, below we present some new specific critical issues including assumptions and response measures.

The timely and efficient implementation of FORVAC include the following new assumptions:

- Utilisation of procured vehicles.
- Enabling working environment for project staff including project office (central and Clusters) and logistics.
- Adequate facilitation of interaction with key authorities at central and local level (for example appointing and clarifying the role of the focal persons at TFS and PO-RALG).
- Minimizing utilisation of funds in unexpected (non-planned) initiatives.
- Political will and support in application of legal framework based on clear roles and mandates.

As in most other countries, the COVID-19 pandemic spread to Tanzania in the end of the first quarter of 2020. It has affected the implementation of the Programme (some delays and postponements of planned activities) and limited traveling of the FORVAC staff as well as stakeholders. Periodically large gatherings have been avoided. The pandemic may still cause changes in implementation of the workplan.

6.2 Sustainability

Sustainability will be searched and developed based on the correct implementation of plans and initiatives aiming at strengthening capacities of beneficiaries at central, regional and local level in order to create a sufficient critical mass of key stakeholders working on development of value chains from natural forest products and services applying best practices including HRBA and relevant cross-cutting aspects. Special attention shall be paid to ensuring sustainability of investments in portable sawmills and solar-kilns.

Specifically, to secure a high standard of Programme implementation and in order to increase impact and enhance sustainability of the intervention, the FORVAC Mid-Term Evaluation, held in March – April 2021, recommends a 2-year extension for the Programme. Moreover, it recommends additional finance for allocation of adequate number of extra working months to the VCDA position and short-term consultancies for the period from now to the original end of the Programme (July 2022). A plan (amendments of the Programme Document, including the Results Framework, specifically indicators and Programme end targets) and budgeting for the Programme extension and the additional finance for Year 4 shall be developed by October 2022.
